#### What we've been doing...

Green Tree Pharmacy has dispensed over 475,000 prescriptions for over 6,000 residents at 120 facilities throughout Illinois and Indiana through August 2022. This averages out to about 60,000 prescriptions per month and about 2,200 prescriptions per day!

#### Rumor vs. Truth...

**Rumor...** I can not administer a COVID bootser and a flu shot on the same day

**Truth...** Both COVID and flu immunizations are in-active vaccines and can be given on the same day. Preferably different arms, or at least 1 inch apart on the same arm.

A person who received a live, injectable vaccine (MMR-11, Varivax) in the past 4 weeks should wait 28 days before receiving another live vaccine.

Inactivated vaccines may be administered at the same time or at any time before or after a live vaccine.

## News from Our Pharmacy Operations Team

#### **COVID Booster Update:**

CDC recommends bivalent COVID-19 boosters to add Omicron BA.4 and BA.5 spike protein components from Pfizer for age 12 years and older and Moderna for 18 years and older. This booster can be given at least 2 months after last vaccination. The previous non-bivalent vaccine is now only approved for 1st/2nd doses. If there are any original Pfizer (gray caps) in fridge, please discard at this time to prevent administration errors, and contact pharmacy if a resident needs a primary series dose.

#### Monkeypox:

The World Health Organization declared Monkeypox a public health emergency. Symptoms of Monkeypox is most commonly a rash on either genitals, hands, feet, chest, face or mouth. rash can initially look like pimples or blisters, and may be painful or itchy. Other symptoms include: fever, chills, swollen lymph nodes, exhaustion, muscle aches, headache, & respiratory symptoms.

Monkeypox can spread through close skin to skin contact, touching objects/surfaces that have been exposed or respiratory secretions. Symptoms usually start within 3 weeks of exposure. Illness typically lasts 2 to 4 weeks.

Eligibility to get vaccinated for monkeypox includes: sexually active men who have sex with men or if around someone who was diagnosed with MPV.

## Regulatory Update

# Dispensing Controlled Substances Policy:

Nursing Removal Procedure:

Nursing is responsible for having a valid prescription authorized by a pharmacist prior to removing any narcotic from the narc box.

An order alone is not sufficient for removal.

DEA regulations do not permit unauthorized removal of narcotics from the narc box and unauthorized use may result in legal action.

The physician can call a prescription into Green Tree. If after 5:30 pm, and the medication is not needed until next business day, a voicemail can be left on the x1038 voicemail. If medication is needed immedicately, the physician can speak to the on-call pharmacist directly.

NOTE: if the prescription was already faxed to the pharmacy, the nurse is to expect that the medication has been dispensed.
Another prescription is needed for removal from the narcotic box.

If the requirements are fulfilled, the nurse may break the red seal on the box and record the removal sheet, immediately faxing to the pharmacy.

Once the red seals have been broken, 2 nurses from each shift must shift count the remaining contents and lock with provided yellow seals.

### Clinical Acorns and Guidelines

#### Flu:

ACIP recommends that adults 65 years and older preferentially receive any one of the following higher dose or adjuvanted influenza vaccines: quadrivalent high-dose inactivated influenza vaccine, quadrivalent recombinant influenza vaccine, or quadrivalent adjuvanted inactivated influenza vaccine. If none of these three vaccines are availble at an opportunity for vaccine administration, then any other age-appropriate influenza vaccine should be used.

The CDC recommends annual flu shots for everyone 6 months and older by the end of October or as soon as possible each flu season.



#### Influenza outbreak:

When 2 cases of laboratory- confirmed influenza are identified within 72 hours of each other in residents on the same unit, outbreak control measures should be implemented as soon as possible.

CDC recommends antiviral chemoprophylaxis for a minimum of 2 weeks and continuing for at least 7 days after the last known laboratory-confirmed influzena case was identified on affected units.

All long-term care facility residents who have confirmed or suspected influenza should receive antiviral treatment immediately.

Antiviral treatment works best when started within the first 2 days of symptoms. However, if at an increased risk for complications, initiate treatment as soon as possible even if > 48 hours have elapsed since illness onset. Do not delay treatment for laboratory confirmation.

Tamiflu (oseltamivir) is most commonly used as an antiviral. Prophylaxis dose: 75 mg once daily. Treatment dose: 75 mg twice daily

Tamiflu is renally adjusted for those with CrCl < 60 mL/min. Contact Green Tree Pharmacy if you need assistance with dosing.



#### **AUVELITY- new FDA Approval 8-22:**

Auvelity is a novel oral combination of **dextromethorphan**, an uncompetitive N-methyl D-aspartate (NMDA) receptor antagonist and sigma-1 receptor agonist, and **bupropion**, an aminoketone and CYP450 2D6 inhibitor.

Auvelity is the first and only rapid-acting oral treatment approved with labeling of statistically significant improvement in depressive symptoms compared to placebo starting at 1 week. It uses a new approach to treat Major Depressive Disorder that is different from other oral antidepressants approved in more than 60 years.

It is available as an extended-release tablet with a start dose of Dextromethorphan 45mg/buproprion 105mg once daily. After 3 days, increase to dextromethorphan 45 mg/buproprion 105 mg twice daily (maximum dose).

It requires dose adjustment for moderate renal impairment and is not recommended with an eGFR < 30 mL/min (has not been studied).

Warning/Caution: seizure disorder (due to bupropion component), increased blood pressure, activation of mania/hypomania – Auvelity is not approved for bipolar depression, psychosis.

Adverse reactions: dizziness (16%), headache (8%), diarrhea (7%), somnolence (7%), dry mouth (6%), sexual dysfunction (6%), and hyperhidrosis (5%).



(dextromethorphan HBr and bupropion HCl) extended-release tablets 45mg/105mg
