MONOvalent Pfizer/ Moderna are no longer authorized for use in the United States.

Only about 17% of people in the US have had a bivalent dose. Adults who have had a bivalent vaccine continue to have a lower risk of urgent care visits and hospitalizations that those who haven't ... even with circulating variants.

Recommend 1 dose of bivalent COVID-19 vaccine for those 6 years and up who haven't had a bivalent dose, regardless of prior vaccination.

Offer a second bivalent dose for patients 65 years and up if it's been at least 4 months since their prior bivalent dose.

New Products:

COVID updates:

The first two respiratory syncytial virus (RSV) vaccines were both FDA approved May 2023 for prevention of lower respiratory tract disease caused by RSV in those 60 years of age and older. Pfizer's product: Abrysvo & GSK product: Arexvy.

Sotaglifozin (Inpefa) is an SGLT2 inhibitor that was FDA approved May 2023 to treat heart failure

Regulatory Update/ Review

USP <800> Hazardous Drugs (HD):

The elements of USP <800> include receipt, storage, compounding, dispensing, administration, disposal, and cleaning.

HD medications that are bulk or in blister cards will be delivered with HD auxiliary labels to alert nursing staff there may be certain PPE required when handling. Liquids will come in HD plastic bag for further protection.

Each facility is responsible for their own policies and procedures on how their employees should handle HD medications and what PPE they feel is necessary.

An Assessment of Risk should be completed for each dosage form of HD medication. Green Tree Pharmacy can provide a list of HD medications that are in their inventory.

It is also suggested to avoid manipulating HD when possible, such as crushing tablets and opening capsules.

PODS:

Facilities should never contact the backup pharmacy directly. Follow Green Tree's On-Call procedure by calling our pharmacy directly and go through PODS, who will contact a backup pharmacy and arrange delivery for you.



Clinical Acorns and Guidelines

Clinical Focus: RSV

RSV is a highly contagious virus that causes infections of the lungs and breathing passages in individuals of all age groups. RSV circulation is seasonal, typically starting in fall and peaks in winter. In older adults, RSV can lead to life threatening pneumonia and bronchiolitis, which can lead to hospitalizations and death. Adults who are at highest risk for severe RSV infection include: older adults especially those 65 years and up, adults with chronic heart or lung disease, and adults with weakened immune systems.

This fall, there will be a first time RSV vaccine, Arexvy by GSK. The safety and effectiveness of Arexvy is based on the FDA's analysis of data from an ongoing, randomized, placebo controlled clinical trial conducted in the U.S. and internationally in individuals 60 years of age and older. Participants will remain in the study through three RSV seasons to continually access the duration of effectiveness and safety of repeat vaccination.

In this study, ~12,500 participants received Arexvy and ~12,5000 received placebo. The participants who received Arexvy, had significantly reduced the risk of developing RSV associated lower respiratory tract disease (LRTD) by 82.6% and had a reduced risk of developing severe RSV associated LRTD by 94.1%.

Abrysvo vaccine by Pfizer efficacy was 66.7% against RSV associated LRTD with at least 2 symptoms and 85.7% with at least 3 symptoms.

The most common reported side effects of both RSV vaccines include injection site pain, fatigue, muscle pain, headache, and joint stiffness/pain.

Both RSV vaccines are reconstituted vaccines administered as 0.5 mL IM.

GSK and Pfizer are expected to have the RSV vaccines available this fall.

Benign Prostatic Hyperplasia (BPH):

About 6 in 10 men develop BPH by age 60... leading to urinary hesitancy, nocturia, a weak stream, etc.

Nondrug measures include limiting fluids at bedtime, alcohol, and caffeine. Reinforce exercise...strengthening pelvic floor muscles may improve bladder control and urination.

Medications such as diuretics or anticholinergics (oxybutynin, etc) may exacerbate BPH symptoms.

Tamsulosin or other alpha-blockers are typically first line.

Doxazosin and terazosin are on the Beers Criteria due to dizziness and hypotension. Any alpha blocker can cause orthostatic hypotension and increase risk of falls. Advise to rise slowly.

Dutasteride or finasteride, a 5-alphareductase inhibitor, can be added to an alpha-blocker if BPH symptoms do not improve after 4 to 12 weeks. However, these can take 6 to 12 months for max effects.

Saw palmetto doesn't seem to have much benefit for BPH, and interacts with blood thinning drugs (aspirin, warfarin, Plavix).

Rexulti (brexpiprazole):

The FDA approved Rexulti for the treatment of agitation in patients with dementia due to Alzheimer's. Originally approved as an atypical antipsychotic used for schizophrenia, or an adjunct therapy for major depressive disorder, Rexulti finds itself alone as the only medication for this indication.
